It should be noted that pursuant to Section 38.13 Texas Penal Code, HINDERING PROCEEDINGS BY DISORDERLY CONDUCT: (a) A person commits an offense if he intentionally hinders an official proceeding by noise or violent tumultuous behavior or disturbance, (b) A person commits an offense if he recklessly hinders an official proceeding by noise or violent tumultuous behavior or disturbance and continues after explicit official request to desist; an,(c) An offense under section 38.15, Texas Penal Code is a Class A Misdemeanor.

Liberty County ESD 3 Meeting Minutes 04/09/2020

Pledge

Meeting called to order at 7:00 PM

Roll Call - Jeff LeBlanc, Lin Pruitt, Bob Johns, Len Jones (Excused), Denny Loonam present and quorum is established

Public Comment

Meeting through Zoom. There were no public comments

Previous meeting minutes

Jeff LeBlanc read previous meeting minutes. Bob Johns motions to accept. Lin Pruitt seconds, minutes approved unanimously.

Treasurer Report

Len Jones was excused. He did email his treasurer report in. Read by Jeff LeBlanc. Due to weird print out some of the totals were unclear. For minutes purposes I have verified the original file sent which is much clearer to read, and have attached it. The board did approve the minutes as read. Below are the actual numbers from the Google Document sent.

Motion to accept Lin Pruitt. Second Jeff LeBlanc. Passed unanimously.

Old Business

Discuss alarm system – Moved to Ewing Security in Hardin. Due to emergency, letter was written and signed by three commissioners. Denny Loonam, Bob Johns & Len Jones for cost of alarm system. Lin Pruitt declined to sign, and Jeff

LeBlanc was unavailable to sign. Total cost for 12 months of service is \$540.00 and the cost of equipment and installation was \$450.00. Total of \$990.00

Clarification – No vote needed, it was approved by the letter and commissioner's signatures in the majority. 3 -1 and one abstention.

Door Lock Price

Denny Loonam explained another door lock was purchased for an additional \$129.00. And the other lock was moved dowr to the end of the bay door. Denny asks for the total to be changed to approve up to \$210.00 for locks. Motioned by Bob Johns. Seconded by Jeff LeBlanc. Passes unanimously. Motion by Bob Johns. Second by Jeff LeBlanc. Passed unanimously

Discuss and take action on budget

Len Jones submitted a proposed budget at the last regular meeting (03/12/2020). Denny does not recall the exact amount (Per minutes it was \$103,000.00 – originally was to go to workshop) He suggests we go with that proposed budget.

Lin Pruitt motions to accept budget. Bob Johns seconded. Motion passes unanimously

Discuss Printer

Just black ink was bought. The printer works fine.

PPE Masks Discuss and take action on new door lock. Not new door. Correction.

40 Masks were bought \$60.00

Jeff LeBlanc mentioned an email from Len Jones about PPE available for purchase

Denny wants to raise the approved \$200.00 for PPE to \$400.00

Bob Johns Motions to raise limit. Lin Pruitt seconds. Motion passes unanimously

Set up emergency meeting for new fire department and ESD to sign contract New contract was signed at emergency meeting on March 20,2020.

Insurance for workers comp was also approved at the emergency meeting on 03/20/2020

New Business

Reimburse Nick Nelson for door lock.

Already motioned an approved under old business. \$129.89

Chief's Report

Chief's report was handed out. All monies were accounted for.

Caleb Anderson read the chief's report

Denny asked if there were any fire calls. Caleb Anderson stated only one shed fire

Bob Johns questioned the money spent on PC repairs. Clarification that was Fire Department expenditure by Jeff LeBlanc. Caleb Anderson stated yes.

Caleb Anderson stated the fire department is requesting \$5,000.00 more toward their contract to cover items needed. Denny clarified that \$5,000.00 was already given.

Jeff LeBlanc clarified that to be clear that would bring them to the total of \$10,000.00 which is half of the contracts and still had 5 more months to go.

Bob Johns motions to pay the department \$5,000.00 Lin Pruitt seconds. Motion passes unanimously.

Motion to accept chief's report Bob Johns. Seconded by Lin Pruitt. Motion passes unanimously.

Discuss Hiring Matthew Gott Attorney

Denny discussed using Gott for local issues as Ken specializes in ESD issues.

Denny suggested we pay half of the fire department's retainer of \$1,000.00

Jeff LeBlanc clarified that if there was a disagreement between the department and the ESD Gott would not represent either side.

Our \$500.00 of the retainer goes towards and legal business we may use, and the fire department's goes towards theirs. Len Jones stated he did receive the request for increase on official letter head. Jeff LeBlanc motioned to pay increase. Bob Johns motions to pay the \$500.00. Jeff LeBlanc seconds. Motion passes unanimously.

Discuss and take action on video conference for next meeting.

Jeff LeBlanc explained that we were using zoom per the Governor's orders since we could not have the public present due to social distancing and the cap on the number of people in a gathering. He explained that video conferencing was allowed so long as the public could participate and that we instructed the public how to use it. All instructions are posted at the first station. We also must provide a local number to call in for those who do not have a PC. This information is also posted. Zoom also records which is also required. Zoom is free for two participants only and for 40 minutes. It was \$14.99 a month + tax and can be cancelled at any time, as we had to allow multiple participants and meeting are longer than 40 minutes.

Motion to reimburse Jeff LeBlanc for the cost of Zoom. Lin Pruitt motioned to approve payment. Bob Johns seconded. Motion passes unanimously.

Discuss and take action on website redesign

Jeff LeBlanc stated that he is working with Denny on shutting the website down. Per the new law, the websites have to be very detailed. Minutes, treasurer reports, as well as spending and income graphs as well must now be included. Jeff wanted to let the public know the website will go down but will come back up once the required information is added. He stated it will take some time, perhaps a couple of months.

No action needed.

Point of information by Jeff LeBlanc

Jeff LeBlanc wanted to assure that we have always served notice of public meetings at the fire station as well as the county courthouse. And, these notices are filed with the clerk's office. Apparently, there was some confusion on what is notice. Denny clarified the agendas are posted and commissioner's copies are in the ESD building and can be picked up at any time after they are made.

Motion to adjourn. Lin Pruitt motions, Bob Johns seconds. Adjourned at 7:48 PM
